## ABOUT THE SIDE EVENT

A preliminary study on mercury trade in the ASGM sector conducted in Indonesia and the Philippines in 2012 by BaliFokus and BAN Toxics revealed that mercury enters both countries through legal and illegal channels.

The study showed that both countries' export-import data and export misdeclarations, among others, resulted in discrepancies with the data released by international trade database such as the UN Comtrade and Global Trade Information System (GTIS).

Improve government coordination, data recording and timely reporting of trade data, and on the ground assessments are some of the essentials for a reliable and accurate mercury trade assessment. As countries gear up for the ratification and eventual implementation of the Minamata Convention on Mercury, a regional dialogue and coordination among mercury exporting and importing nations is needed.

As part of the regional effort in supporting the early ratification and implementation of the Minamata Convention, BaliFokus of Indonesia, BAN Toxics of the Philippines, with support from IPEN and the Zero Mercury Working Group, would like to invite all interested delegates to attend a preliminary dialogue on mercury trade in the Southeast Asian region.
